11/8/1884		Granting the Ohio River and Lake Erie Railroad Company the right to construct and operate a railroad in the Borough.
11/7/1885		Granting the privilege to the Greenville Water Company to dig and use the streets for the purpose of laying mains and pipes to supply water to the Borough.
4/7/1891		Granting the Peoples Electric Light Heat and Power Company (a.k.a) Pennsylvania Power Company the right to erect and maintain poles and wires for the purpose of conducting electricity throughout the Borough.
9/10/1896		Granting a contract with the Greenville Water Company for water for fire and other purposes for 5 years.
6/10/1901		Granting a contract with the Greenville Water Company to provide water for the Borough.
114	10/10/1901	Contracting with Peoples Electric, Light, Heat and Power Company for sounding fire alarms for 2 1/2 years.
137	8/1/1904	Authorizing the Greenville Natural Gas Company to enter and lay down its pipes under the streets, alleys, highways and public grounds in the Borough.
223	11/6/1912	Granting a five year street lighting contract with Mercer County Light, Heat and Power Company.
279	12/17/1915	Contracting with the Greenville Water Company for water for fire and other purposes for 10 years.
296	4/10/1917	Granting a contract with the Mercer County Light, Heat and Power Company covering a period until January 15, 1928.
343	6/12/1923	Granting the Bell Telephone Company of Pennsylvania permission to construct, maintain and operate its conduits, ducts, mains, pipes, cables, wires, manholes, terminals and distributing poles and all other necessary underground appliances.
394	12/12/1927	Granting a five year lighting contract with the Pennsylvania Power Company.
450	2/17/1942	Granting the right to maintain and operate the water distribution to the Municipal Authority of the Borough of Greenville.
