

**MINUTES OF THE RE-ORAGANIZATIONAL MEETING
OF GREENVILLE BOROUGH COUNCIL

1. Swearing in of Mayor Miller:

Frances J. Fornelli, President Judge, Court of Common Pleas, Mercer County and Senior Judge Michael J. Wherry swore in Richard H. Miller as Mayor of the Borough of Greenville.

2. Swearing in Councilpersons:

6. Nominations and election of Council Vice President:

7. Nominations and election of Chairperson Pro Tem:
