

**MINUTES OF THE REORGANIZATIONAL MEETING  
OF GREENVILLE BOROUGH COUNCIL  
HELD IN THE COUNCIL CHAMBERS  
ON MONDAY, JANUARY 7, 2008 AT 6:30 p.m.**

**1. Call to Order:**

Pete Longiotti called the meeting to order at 6:30 p.m.

**2. Swearing in Councilpersons:**

After a brief history on the swearing in ceremony, the Mayor congratulated the newly elected council members and swore them into office. Mayor Miller swore in Pamela Auchter, Alfred Peden, and Brian Shipley to Greenville Borough Council.

**5. Nominations and election of Council President:**

**6. Nominations and election of Council Vice President:**

President Longiotti asked for nominations for Vice President. Councilor Henderson nominated Pamela Auchter to fill the position of Vice President, seconded by Henry Mueller. Council President Longiotti asked if there were any other nominations, with none, he instructed the Secretary to cast a unanimous ballot for Pamela Auchter for Vice President of Council.

**7. Nominations and election of President Pro Tem:**

Councilor Auchter nominated Jasson Urey to fill the position of President Pro Tem, seconded by Henry Mueller. President Longiotti asked if there were any other nominations, with none, he instructed the Secretary to cast a unanimous ballot for Jasson Urey for President Pro Tem.

**8. Nominations and appointment of Chairperson for Vacancy Board:**

Councilor Auchter nominated Kate Yasgur to fill the position of Vacancy Board Chairman, seconded by Henry Mueller. President Longiotti asked if there were any other nominations, with none, he instructed the Secretary to cast a unanimous ballot for Kate Yasgur for Vacancy Board Chairman.

- c. **Code Enforcement/Zoning Officer** – Councilor Auchter moved, seconded by Councilor Urey re-appoint George Pangas as Code Enforcement/Zoning Officer for a one year term. Motion approved.
- d. **Borough Solicitor** – Councilor Auchter moved, seconded by Councilor Mueller to appoint Douglas & Joseph as Borough Solicitor for the year of 2008. Motion approved.
- e. **Borough Engineer** – Councilor Urey moved, seconded by Councilor Auchter to appoint HRG Engineering as Borough Engineer for the year 2008. Motion approved.
- f. **Code Board of Appeals** – Councilor Henderson moved, seconded by Councilor Urey to re-appoint Mr. William Butler to a 5 year term on the Code Board of Appeals. Motion approved.
- g. **Greenville Municipal Authority** –
  1. Councilor Henderson moved, seconded by Councilor Auchter to re-appoint Mr. Gary Beatty to a 5 year term on the Greenville Municipal Authority. Motion approved.
  2. Councilor Mueller moved, seconded by Councilor Auchter to re-appoint Mr. David Henderson to a 5 year term on the Greenville Municipal Authority. Councilor Henderson abstained from the vote. Motion approved 6-1.

3. Councilor Urey moved, seconded by Councilor Henderson to appoint Mrs. Joanne Price to a 5 year term on the Greenville Municipal Authority. Motion approved.
- h. **Greenville Planning Commission** – Councilor Mueller moved, seconded by Councilor Urey to re-appoint Charles Demarest and Jonathan Bailey to a 4 year term on the Greenville Planning Commission. Motion approved.
- i. **Greenville Zoning Hearing Board** – Councilor Urey moved, seconded by Councilor Auchter to re-appoint Ms. Thea Arai to the Greenville Zoning Hearing Board. Motion approved.
- j. **Airport Commission** – Councilor Mueller moved, seconded by Councilor Henderson to re-appoint the following people to the Greenville Airport Commission for a one year term. Councilor Urey abstained from the vote. Motion approved 6-1.
