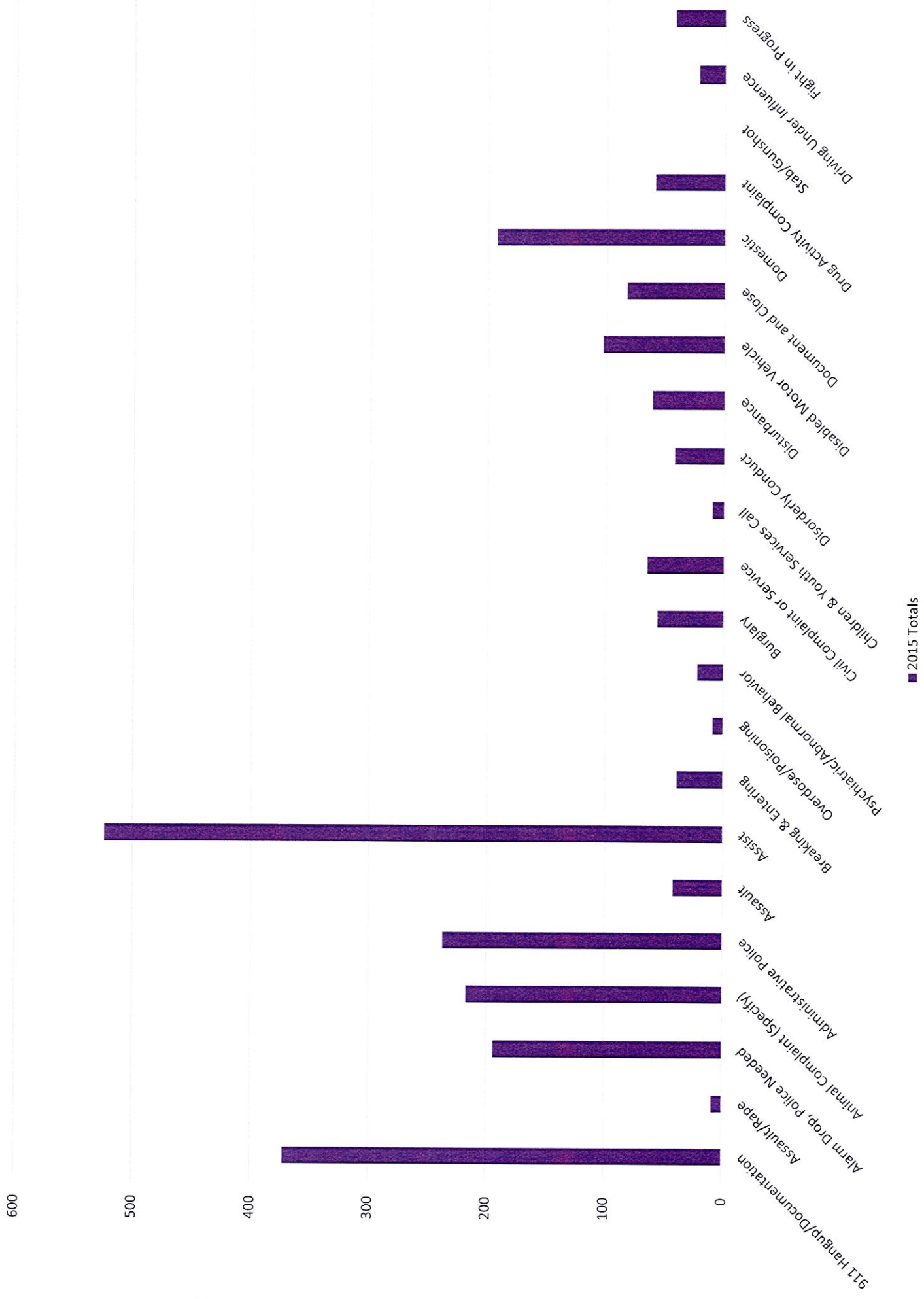

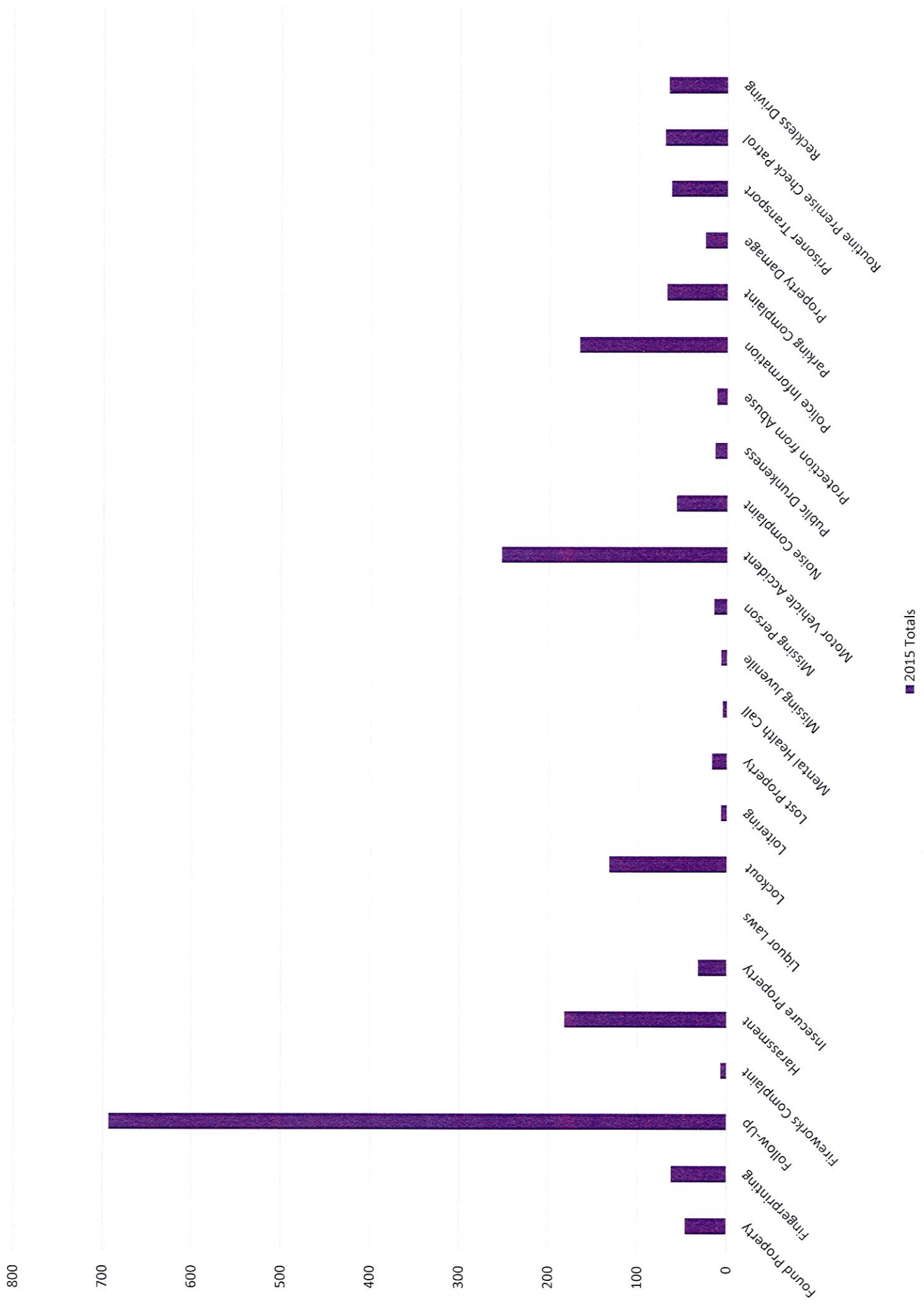

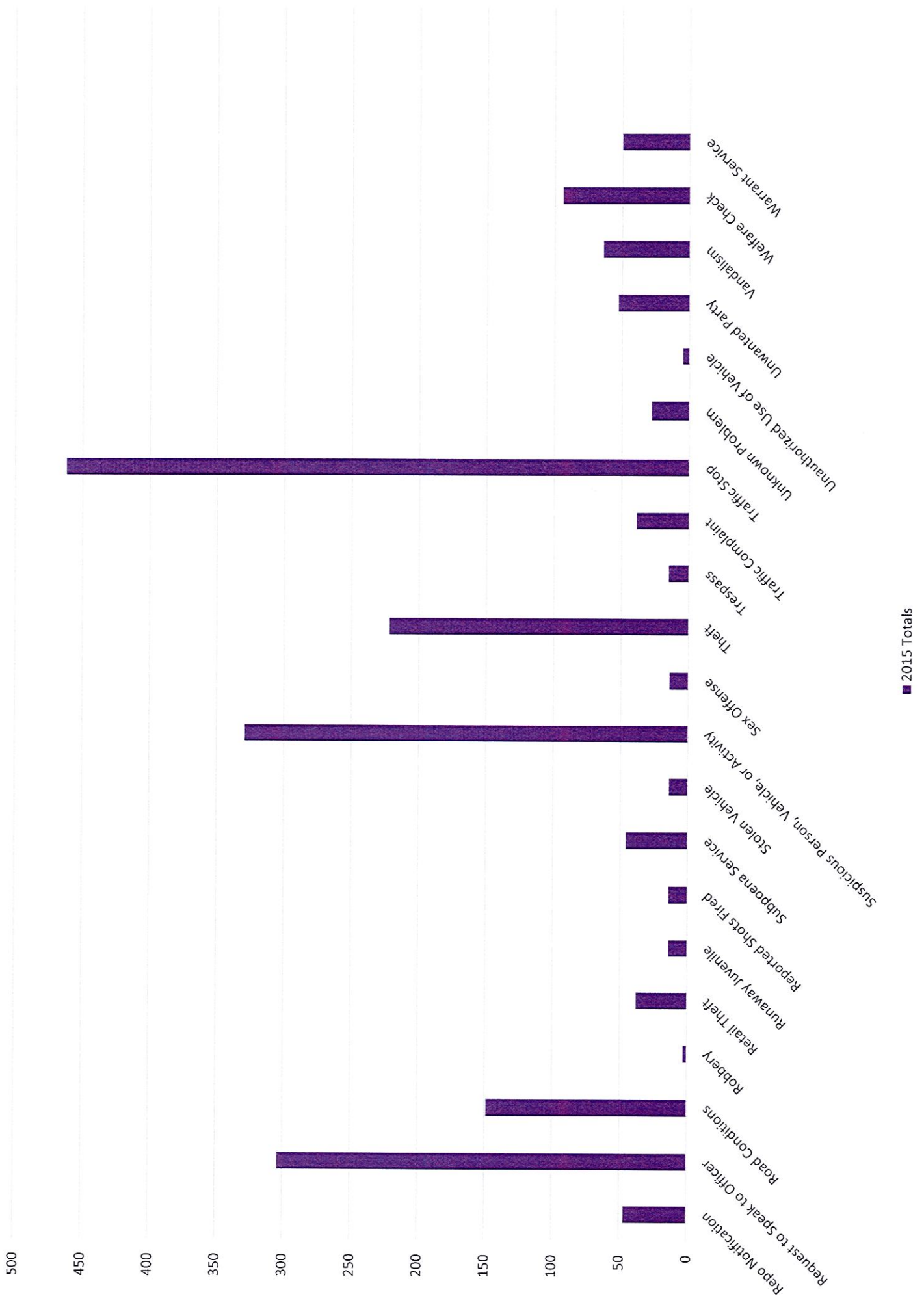

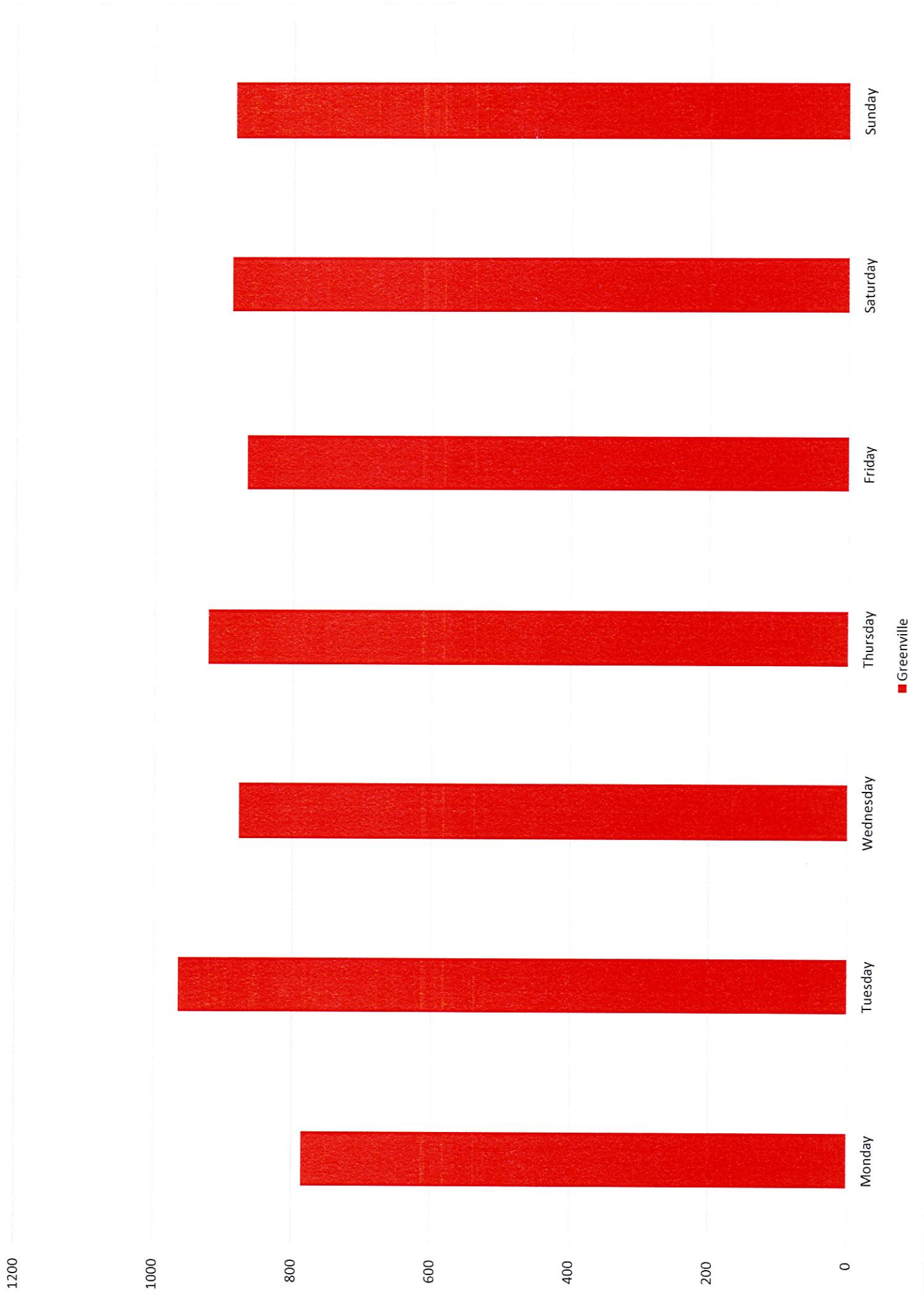
2015 Total Incidents, Page 2



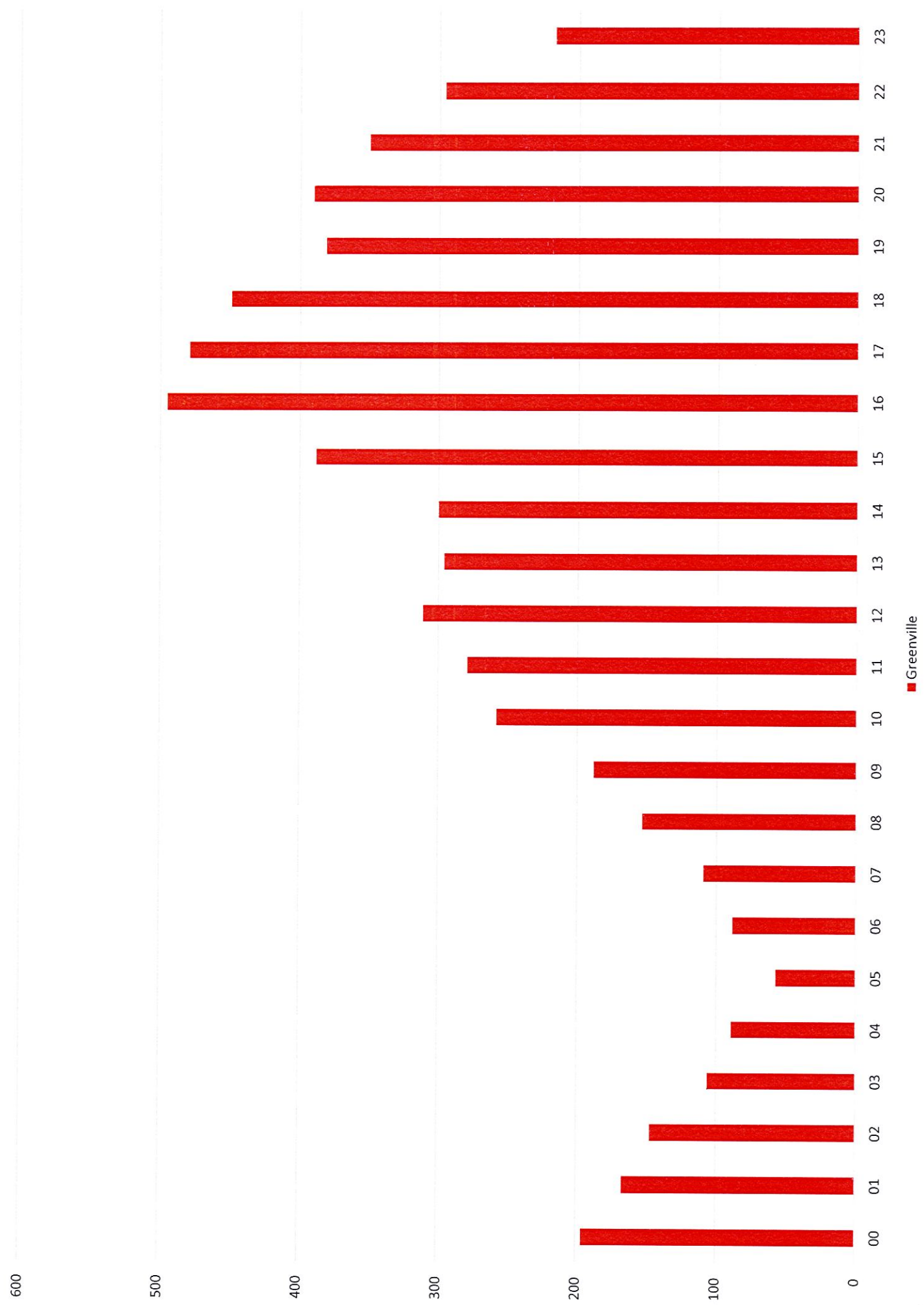

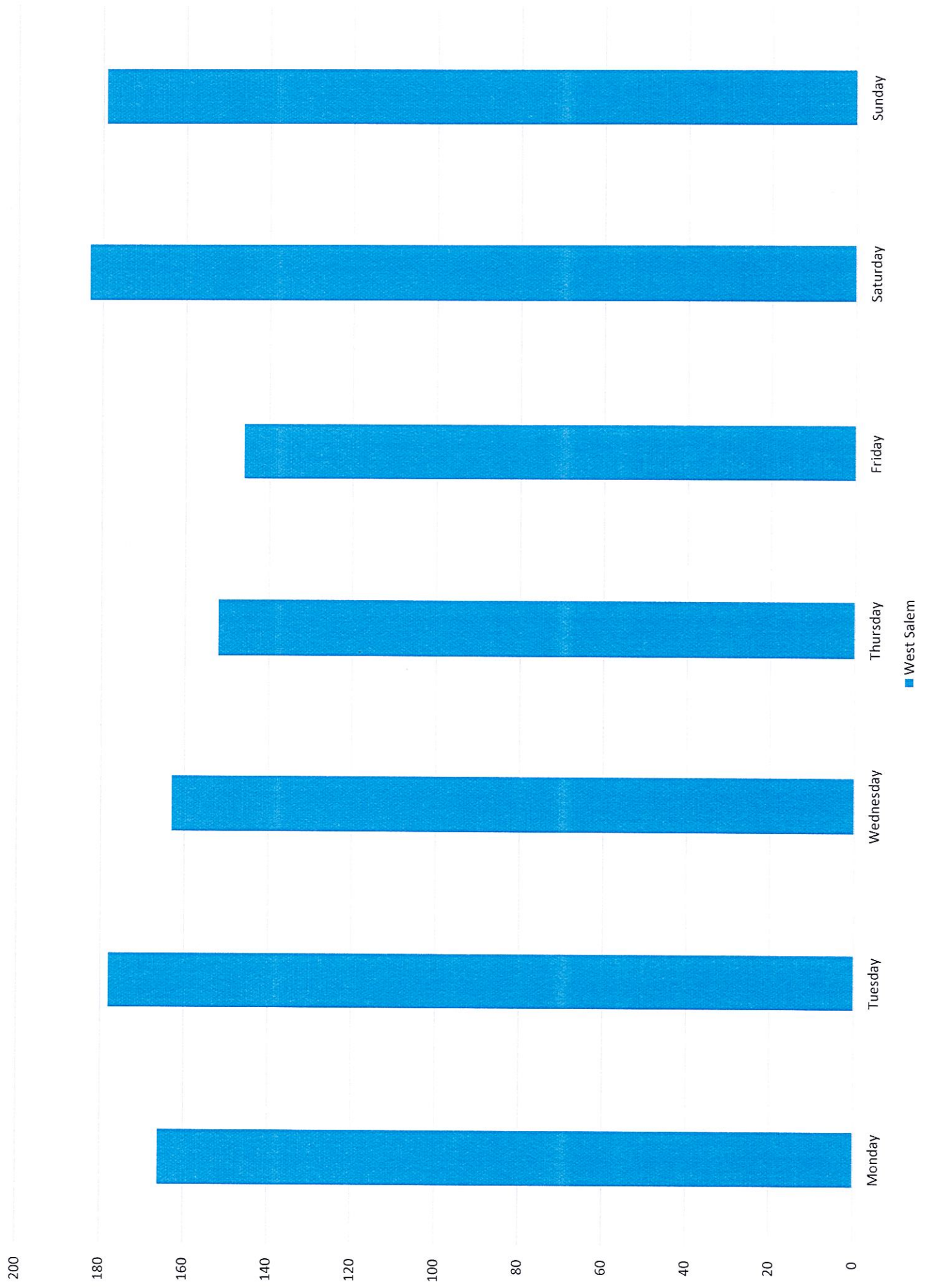
2015 - # of Calls by Day - Greenville



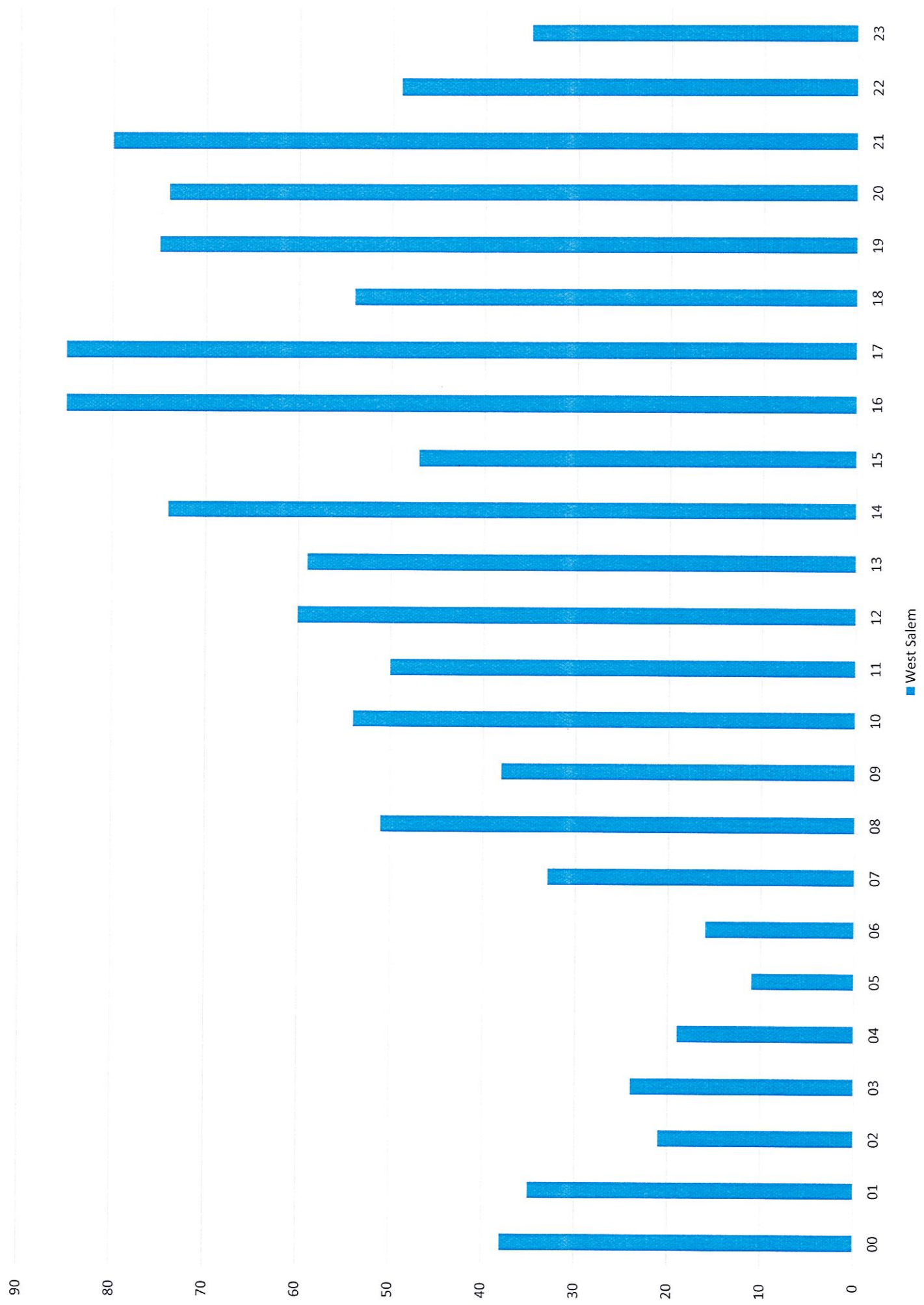
2015 - # of Calls by Time - Greenville
